



COVID-19 VISITOR GUIDELINES AND SCREENING INFORMATION

Before visiting your loved one at the Abramson Center for Jewish Life, we ask that you please review the visitor guidelines outlined on the next sheet. These guidelines were developed following recommended CDC and PA Department of Health protocols and are designed to keep both you, your loved one and all of our residents and staff members as safe as possible. Failure to follow the guidelines can result in suspension of visiting privileges.

As of July 15, 2020, if you are visiting from the following states: Alabama; Arizona; Arkansas; California; Florida; Georgia; Idaho; Iowa; Kansas; Louisiana; Mississippi; Nevada; North Carolina; Oklahoma; South Carolina; Tennessee; Texas; and Utah, you must self-quarantine for 14 days before visiting our campus. This list is in accordance with Pennsylvania Department of Health travel recommendations and is subject to change at the Department's direction.

Additionally, all visitors must fill out a symptom screener before each visit with their loved ones. When you arrive, your temperature will be taken at the door. You can find the screener on the third page. To save time at your visits, please print and fill out the sheet before you arrive.

All visits for Abramson Residence must be scheduled and can be done so by calling 800.532.8016. To schedule a visit at the Mildred Shor Inn, please call 215.371.2102.

We thank everyone for their continued patience and understanding as we work to safely create a new normal for our residents. We look forward to welcoming you all back to our campus!

Visitor Guide

Help us ensure the safety of our residents by following these guidelines for visitation:

Window Visits

- Visitors to Abramson Residence are welcomed to schedule a window visit by calling 800.532.8016. Visitors to the Mildred Shor Inn can call 215.371.2102.
- Window visits are held Monday through Friday at designated times and spaces.
- At the time of the appointment, your loved one will be escorted and accompanied to the defined visitation area and provided a sanitized cell phone to aid in clear communication.
- A bench is provided in the shaded/covered window visit space for visitors and the visit period is 20 minutes to allow for as many residents to visit with their loved ones as possible.

Modified Outdoor Visitation

- *Visitors will be welcome to engage in outside visits once the secretary of health allows such visits in long-term care settings.*
- Outside visits will be held in designated garden areas with no more than two visitors per resident. **No children or pets at this time.**
- Outdoor visits for Abramson Residence may be scheduled by calling 800.532.8016. For the Mildred Shor Inn, please call 215.371.2102.
- At the time of the appointment, your loved one will be escorted and accompanied to the defined outdoor visiting area and escorted back to their household by an assigned staff person or designee.
- Visitors agree to the following:
 - Screening prior to entry – guests may download the screener on the Abramson Senior Care website, or obtain a form at the front entrance.
 - Visitors may also be asked to present a recent negative test result, as applicable.
 - Visitors must wear mask at all times while on campus. The mask must be worn properly – covering the entire nose and mouth. The resident will also be required to wear a mask during an outdoor visit. Additional PPE may be required depending upon the recommendation of the infection preventionist.
 - Visitors will be required to sanitize their hands upon entering the facility to reach the outdoor destination.
 - Visitors may only travel to the designated visitor area, and shall lose visiting privileges if they are identified as having disregarded safety standards established within this guideline.
 - Visitors are directed to use the restroom at home prior to visiting as the campus restrooms will not be open to the public.
 - Following the visitation time, visitors are to exit the building promptly and inform front desk staff that they are leaving the building.
 - Visitors are to refrain from physical contact with the resident during the visit, and refrain from eating or drinking during the visit to promote adequate mask wearing.
 - If weather does not permit an outdoor visit, a window visit will be accommodated.
